Trial Location

All trials will be held outdoors at Auke Bay Elementary School (in the covered play area), 11869 Glacier Highway.

Directions: From the Airport or downtown, drive on Egan to just past Auke Bay Harbor. The entrance to the school is on the right, just past the Squire's Rest.

From the ferry terminal, drive towards downtown on Glacier Highway, approximately 2 miles. The entrance to the school is on the left, just before Squire's Rest.

The trial site is behind the school, in the covered play area.

Ring Conditions

Rally Trials: Outdoors in covered play area, concrete, partially matted ring.

Obedience Trials: Outdoors in covered play area, fully matted ring on concrete.

Entry Information

Closing Date: **Pre-entries must be received by August 20, 2010.** Entries will be taken the day of trial (see Trial Schedule below).

Move Ups: Move ups will be accepted at all trials. Please notify the Trial Secretary no later than 15 minutes before judging begins.

Special Information: Entries must include the dog's UKC registration number. Forms and information about registering your dog are available on the UKC website at www.ukcdogs.com

Payment: No faxed or email entries will be accepted. No credit card payments are accepted.

Fees per trial: Pre-entry \$18 per dog for each class entered. Day of trial \$25 per dog for each class entered.
