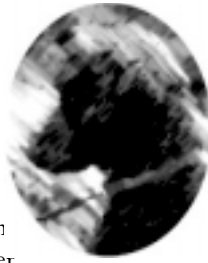


Water Dog News

WHAT IS RALLY OBEDIENCE?

Recently there has been a lot of discussion in dog circles about Rally Obedience. Rally Obedience is a relatively new performance even that tests the obedience skills of a dog/handler team, but does so in a style that is similar in some ways to agility. Rather than going through a series of exercises at the direction of a judge, in Rally Obedience a course is set, using signs to describe the exercise to be done at each stage in the course. After the judge's "Forward" command, the team is on their own to complete the entire sequence correctly. The handler has the dog heel from sign to sign and performs the exercise indicated by the sign. Examples of the exercises are "Right Turn", "Slow Pace", "Turn and Call Dog Front", "Straight Figure 8", etc. Some of the exercises combine two or more obedience skills, or add additional challenges such as doing an offset figure 8 around bowls of dog treats!

Unlike traditional competitive obedience, in Rally Obedience handlers are encouraged to communicate freely with their dog. As in agility, unlimited commands and praise are allowed. Scoring is similar to



competitive obedience – each team starts with 200 points and minor or major deductions are taken for any errors in performing the designated exercises. At Level 1, all exercises are performed on leash, with 16 – 20 exercise signs. At Level 2, exercises are performed off leash, with 18 – 22 exercise signs. More challenging exercises are added at Level 2.

Rally Obedience is not yet a UKC-licensed event, but we could still give it a try just for fun! I think that Rally Obedience would offer variety for those training for competitive obedience. It could also be a good way for those who aren't interested in competing to practice and test their dog's skills. Those participating in agility could use it as a technique to work on increased control with their dog.

Because several people have expressed interest in trying out Rally Obedience, the club has ordered a set of signs and a book of course designs. I think that it would be great to have a Rally Obedience Fun Day next spring or summer! The Fun Day would give teams a chance to learn the different exercises then complete courses to try out their skills. The day could include other fun things like doggie games and a club picnic.

IV. Approval of Minutes -October 28, 2000 read and approved with the following corrections: Spelling of Vicky McLaughlin, Bob Shaw, Cindy Britten. Under Treasurer's Report, change the reference to a small deficit of the gaming account, to the more specific: "Although there is a small monthly service charge, Gabrielle recommended keeping the account open until December and revisiting this decision then." M/Susan, S/Aran to approve minutes with corrections. A/UC.

VI. Treasurer's Report by Susan. SR met with Michelle Grose. Some of Michele's recommendations include: Cash Flow report name changed to Income Statement report. Need a balance statement, but first needed to create an accurate asset list. Reviewed all reports. Cash report and Doggie Dollars need to be separate reports. As long as the club doesn't make over \$25,000 gross, we do not need to fill out a 9-90. Overall, she felt the bookkeeping procedures were fine.

Michelle will submit her recommendations in writing. Treasurer's report approved, M/AF, S/DG, A/UC.

VII. Committees

A. Training Committee - new coordinator is Vicky. Sunday @ 2:00, training committee will meet.

1) Scheduling space for upcoming classes -open and CGC classes (Linda and Perry), Gaile (basic), Conformation/obedience combo (Susan). March 10 obedience trial with two ring run-throughs scheduled February 24, March 3.

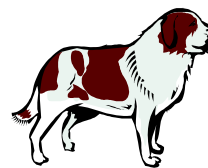
