MINUTES

Minutes for the CKCOJ Monthly Board Meeting
Held at the Valley Library, Thursday April 15, 2004

1. **Call to order.** Board members present: Camille Stephens, Gina Vose, Barb Deyell. Club members present: Jill Grose, Sue McGregor
2. **Consent agenda**
 - a. Approval of agenda. Approved by unanimous consent
 - b. Approval of new members. Marian Montoure, Hollon Stevens and Jan March. Marty Messick has upgraded her membership to a family membership.
 - c. Approval of March minutes. Approved by unanimous consent
 - d. Acceptance of Treasurer's report. Unavailable.
3. **Action items**
 - a. Agility Expenses. Pete & Gina have finished resurfacing the dog walk, A-frame and teeter totter. Original expenditure authorized for this was \$500. Cost of materials was \$390.89 with over 20 hours of labour. Proposed to pay Pete & Gina \$600 to cover materials and labour (\$400 in cash, \$200 in doggie dollars). Unanimous consent.
4. **Discussion items**
 - a. Public Relations Position. Linda Shipman has volunteered to become the club's new PR person & Advertising Coordinator. She will take over placing ads in the Empire for classes, etc. Unanimous consent
 - b. Doggie Dollars. Proposed to pay \$5 per month in doggie dollars for the new PR person and the club's representative on the Dog Task Force. Unanimous consent.

- c. Dog Task Force. Sue presented a thorough update on the current dog task force recommendations. The recommendations include making the following trails on leash only: Brotherhood bridge paved trail, Rainforest trail (Apr 1-Sept 30), Fish Creek, Mt. Roberts Tram to Gold Ridge, Twin Lakes picnic area/hill, Switzer trail system, Sandy Beach Trail. The following trails would be off-leash allowed: Brotherhood bridge side trail (next to the river), Rainforest trail (Oct 1-Mar 31), Outer Point trail (this may change depending on which trail is used for commercial use), Sandy Beach (below the tide line), Dredge Lakes area, Switzer trails (uphill of the clear-cut), Twin Lakes (from the end of the open grassy area), sports fields. The following trails would not allow dogs at all (leashed or not): Police Station, Amalga Meadows, DZ trail system, Auke Lake trail, new Spur trail (east pond dike). At this time, recommendations were yet to be made on the Airport Dike Trail and the Eagle Beach area.
 - d. Storage unit keys. Sue turned in the remaining keys for the storage unit.
