This is a preparation class for dog and handler teams interested in participating in the Canine Good Citizen Test. Please call Sue prior to the first class to discuss the details and let her know why you are attending this class (to take the test vs. more training experience).

- Prerequisites:** The dog must demonstrate the ability to obey simple commands and be able to walk on a leash.
- Equipment needed:** a buckle or slip collar made of leather, fabric or chain (no pinch collars or head halters) and a 4 or 6 foot leash made of leather or fabric (no Flexi-type leashes). Please bring treats!

There will be a CGC test following the last session (dates and times to be announced). **The CGC test is a prerequisite for certification as a Therapy Dog.**

1. All entries must be submitted on the official "UKC Entry Form".
2. You may use one entry form to enter the same dog in more than one event on the same weekend.
3. Use separate entry form for each dog to be entered in a club's event.
4. Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at <https://host.securelook.com/ukcsec/tlapp.html>. TL numbers are valid for 60 days - fee \$12.00. (Fees are non-transferable and do not apply to the cost of permanent registration.)
5. Mail all completed entry forms to the Event Secretary listed under the event, unless otherwise specified.
6. Make all fees payable to the host club.
7. Obedience Trials, Agility Trials and Weight Pull events are open to all UKC recognized breeds and mixed bred dogs with a valid Limited Privilege number.
8. Obedience only: Check the box provided to request either the Veteran or Special Jump height option. Veteran dogs must be 8 years or older. Eligible dogs for Special Jump Heights are outlined in the current rules and regulations.

- All entry forms must be complete and signed. Incorrect information submitted on the entry form may invalidate your wins.
- To be eligible to enter into the Breeder/Handler class, you must be one of the breeders of record, or a member of the immediate family of one of the breeders of record. Immediate family includes: spouse, parent, step-parent, child, step-child, brother or sister.

Absolutely no alcoholic beverages or illegal drugs will be allowed on the grounds or in the buildings on the day of a UKC-licensed event.
