- I. Call to order by president DeeAnn Teseneer at 6:58 pm. Board members Jill Grose, Vicky McLaughlin, DeeAnn Teseneer and George Utermohle were present. A quorum was established.
- II. Consent agenda
 - e. An approval of the agenda was made after additions were submitted and agreed upon by members present.
 - f. Approval of a new member Malene Babcock / Adult membership was unanimous.
 - g. Approval of April's board meeting minutes was passed by the board.
 - h. The board approved the Treasurer's report with amendments.
- III. Discussion items
 - a. There was a lack of a quorum for the general membership meeting scheduled for April, therefore no official action was taken.
 - b. CGC / TDI liaison for the club was proposed by Vicky due to the increase in questions from the public. The board was in agreement about establishing a liaison. We will look for a volunteer.
 - c. Several members of the club have expressed an interest and are willing to volunteer to become CGC evaluators.
 - d. Quorum / no quorum will be indicated by the secretary in the monthly board meetings and general membership meeting.
- IV. Action items

 - b. A funding request for prizes for 4th of July agility demo was brought forward. DeeAnn made a motion for allocating \$25 for dog and handler treats for the 4th of July agility demonstration participants. The board approved the motion.
 - c. Jill made a motion for the board to approve the Juneau Agility Constitution as amended, and to authorize her to send it to AKC for their acceptance. The motion passed unanimously.

 - a. Correspondence included an update from the insurance company indicating our purchase of new equipment put us in a higher payment bracket for coverage. George submitted a check to cover the increased cost.
 - b. Event Planning

 - ii. July Rally O Trial – Vicky booked a bed and breakfast room for Kris DuRocher Wilson. She will make a change in the premium about a completely matted ring.
 - iii. August Agility Trial- Vicky will book a room for the judge Doug Ricks.
 - iv. September UKC Obedience Trial will be held at Glacier Valley covered playground.
 - v. Patricia McConnell seminar June 2007 – Sue McGregor submitted a seminar detail update sheet.
 - c. Education Committee will meet in August to develop at timeline of upcoming classes.

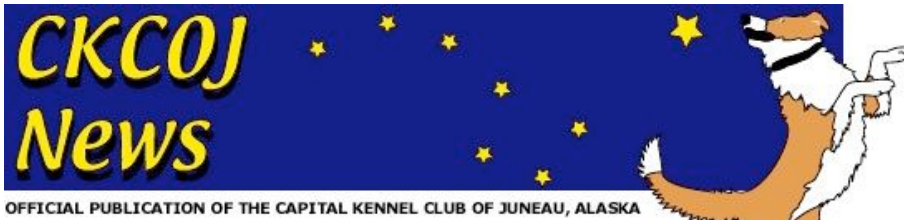
