I. Call to Order

This regular meeting was called to order at 6:35 p.m. by Grose, President, a quorum was present.

II. Consent Agenda

- a. Approval of the Agenda – approved unanimously with addition of IV. d. Kim Hastings Request for Hoops, and IV. e. Kim Hastings Request for Gates.
- b. Approval of the Previous Minutes, June 21, 2007 – approved unanimously.
- c. Acceptance of the Treasurer's Report – After review Hoffman found a date error on Doggie Dollar Report; 05-06 was used instead of 06-07, in column headings. Motion: by Grose, 2nd by McLaughlin to accept the reports as submitted with an amendment to the headings on Doggie Dollar report. Passed unanimously.
- d. Approval of New Members – Applicants Rachel and Molly Sanders, Douglas and Ruth Devorak. Approved unanimously.

III. Discussion Items

- a. Club Historian – McLaughlin informed the board that Reynolds is not interested in being Historian, however, she has volunteered to take pictures of events. McLaughlin will write up something for the newsletter regarding recruitment of a historian to find if some in interested.
- b. Planning Annual Meeting – There was a general discussion followed by suggestions by those in attendance. Motion by Grose, 2nd by Barnes to have a business meeting followed by an annual meeting at the library on the regular meeting date; and, an awards/potluck on a separate date. Passed 4 yeas, 2 nays. The Board is seeking suggests on where to hold the awards/potluck.
- c. Nominating Committee – McLaughlin and Grose volunteered. Grose will follow up with finding a third volunteer not on the Board.

IV. Action Items

- a. Responsible Dog Owner Day – Nelson reported that it will be held on September 8th at the Nugget Mall. She is preparing a list of events, classes and activities available through the club, as well as, a display. Grose will supply business cards and put an agility demo together. McLaughlin will put a Rally-O demo together. Aran Felix will be contacted about putting together a demo for competitive obedience. The demos will be at scheduled times. Demo dogs will need to enter through the rear of the mall. The space available is the old Borderline store. Nelson is going to pursue the purchase of pens with club logo to have available as handouts.

- b. Obedience Equipment Purchase – Hoffman reported on the poor shape of the equipment bag. She will be able to purchase a new one for \$45.00 plus s&h from J and J. The Board approved the purchase.
- c. Purchase of Rally-O Supplies – McLaughlin requested approximately \$200.00 for a complete set of short stanchions and containers to keep them in, plus, new signs, laminating and printer cartridges. The Board approved the purchase.
- d. Hastings Request for 15 Hoops – Request is for \$120 and the Board approved it. Grose will let Hasting know.
- e. Hastings Request for 6 Gates – Request is for \$50 and Hasting will make them. However the judge is open to substitutes. Utermohle is going to contact Hastings to find out if the club owned baby gates will be an adequate replacement.

Mc Laughlin reported that the Rally-O Trial begins tomorrow and continues on Saturday. Not a lot of entries and it should go quickly. McLaughlin will be working with Hocker regarding an April trial.

An Agility Trial Status Report written by Hastings was submitted. In the report are suggested charges. The Board suggested the charge for the workshop be \$10 and if you are a volunteer working at the trial all day, and not competing, the fee is waived. This was approved unanimously.

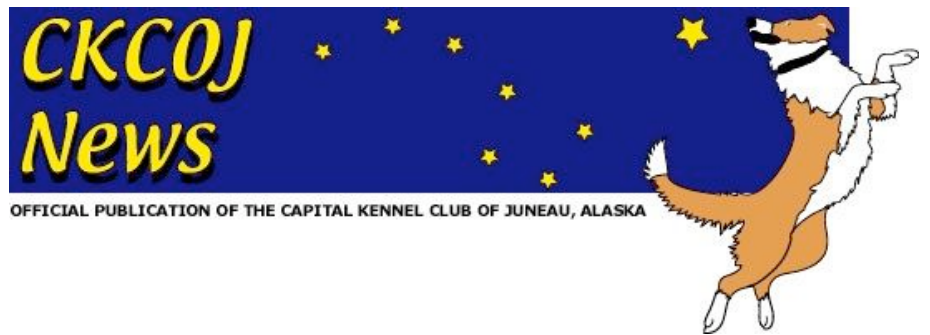
