## MINUTES

CKCoJ Monthly Meeting  
Thursday, **December 20, 2007** – Valley Library

- I. Call to Order: This regular monthly meeting was called to order by Grose, President, at 6:40 p.m. Board members present: Grose, McLaughlin, Nelson, Uttermohle, Barnes. Members present: Hoffman, Stephens.
- II. Consent Agenda
  - a. Approval of the Agenda – add two items; III. a. Minutes and III. b. Class Addition. Approved.
  - b. Approval of Previous Minutes, Nov. 15, 2007 – approved with the following changes. Under IV. A. Donation to California Federation of Dog Clubs; add: A vote was taken to send a \$100 donation. The vote was 1 nay, 2 abstentions and 5 yeas.  
Under III. a. New Agility Equipment Funding; add: The vote was 2 abstentions and 6 yeas.
  - c. Acceptance of the Treasurer’s Report – the report submitted by Utermohle was approved. Utermohle informed the membership that once a year an annual report will need to be submitted to the federal government in lieu of a tax return. The club will be notified by an on-line e notice.
  - d. Approval of New Members – Maryann Clough and Marina Miller, Pat Kalbaugh, Michelle Grose-Bray. All approved.
- III. Discussion Items
  - a. Minutes – A discussion of changing the way votes are recorded took place. This discussion centered on recording the names of those who vote and how they vote. It was decided that if a member wants their name with how they vote, then they will express this to the secretary for recording at the time of the vote. An additional item to this discussion was email sent to board members. It was decided that email sent to board members should be brought to meetings and presented during item V. c. Correspondence.
  - b. Class Addition – McLaughlin for Felix proposed a Junior Rally class. At this time Felix doesn’t know how many would be interested. She is going to contact the 4H club as a source for interest. It was brought up that a minimum of 4 participants is required. Felix was given the go ahead to begin putting a class together.

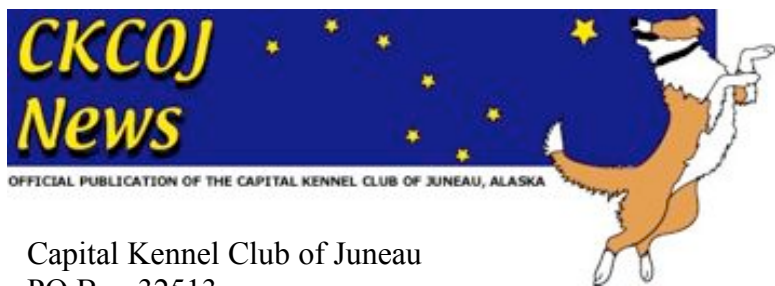
