MINUTES  
CKCoJ Monthly Meeting  
Thursday, March 20, 2008 – Valley Library

- I. Call to Order: This regular monthly meeting was called to order by Grose, President, at 6:35 p.m.  
Board members present: Grose, McLaughlin, Nelson, Utermohle, Barnes.  
Members present: Hoffman, Stephens, Kalbaugh.
  
- II. Consent Agenda
  - a. Approval of the Agenda – add items: III. f. Equipment Inventory and Check Out, and; IV. a. Historian, IV. b. Agility DVD Purchase. Approved.
  - b. Approval of Previous Minutes, Jan.17, 2008 – approved with the following change. Under IV. Discussion Items, Hoffman requested her comments include her request that the proposed policies go to committee.
  - c. Acceptance of the Treasurer’s Report – the report as submitted by Utermohle was approved.
  - d. Approval of New Members – Leann Thomas, Shelley Long, Harriet Culver, and Paula Terrel. All approved.
  
- III. Discussion Items - Grose asked Nelson if the club received any emails regarding the discussion items, a. through e. Nelson reported that no emails were received.
  - a. Voting Procedures – comments from membership  
Voices in favor of the proposed procedure and opposed were heard.  
**Motion** by Grose, to move item a. to committee. Not seconded.  
McLaughlin excused herself from the meeting.  
**Motion** by Grose, to move item a. from Discussion to Action Items. Not seconded.  
**Motion** by Utermohle, to table item a. Seconded by Grose. Approved; 6 yeas, 1 abstention.Items b. through e. were then moved to the end of the agenda.
  - e. Equipment Inventory and Check Out - The need for an inventory and check out sheet for equipment was discussed. Kalbaugh volunteered to inventory the equipment and put a sign out sheet in the storage facility.

#### IV. Action Items

- a. Historian – Patti Kalbaugh has accepted the position and requests members contact her if they possess any club related items they think usable or not.
- b. Agility DVD Purchase – Grose requested the club purchase a 4 DVD set by Susan Salo called “Foundation Jumping”. Grose wants to use these as a reference for her classes and then put in the club library. The price is approximately \$76.00.

**Motion** by Utermohle, seconded by Barnes, to approve the purchase of the DVD set with a limit of \$80.00 spent. Approved; 6 yeas, 1 abstention.

#### V. Routine Updates

- a. Event Planning – Stephens submitted and then reviewed a cost proposal for upcoming UKC Obedience Trials to be held Sept. 20-21, 2008. Lisa Barnard has tentatively agreed to judge.

**Motion** by Utermohle, seconded by Grose, to approve the proposal. Approved; 6 yeas, 1 abstention.

- i. Status Report on Agility, Rally-O and Obedience

Stephens reported on some purchases she made, i.e. ribbons (\$488.59), tape measures (\$5.25), and gift certificates for visiting obedience judge, Arlene Courtney (\$75) and her hostess, Alexis Rippe (\$100.00). She submitted a detailed list to Utermohle for reimbursement.

Kalbaugh reported that her class, Competition Obedience Skills Workshop I, is full. The class will be for 7 weeks and meets mainly at Glacier Valley. She is also considering some fun matches to help develop interest in obedience.

- b. Committee Reports – none.
    - c. Correspondence – Utermohle displayed the mail received over the past month. There were no items of business. Barnes will recycle it.

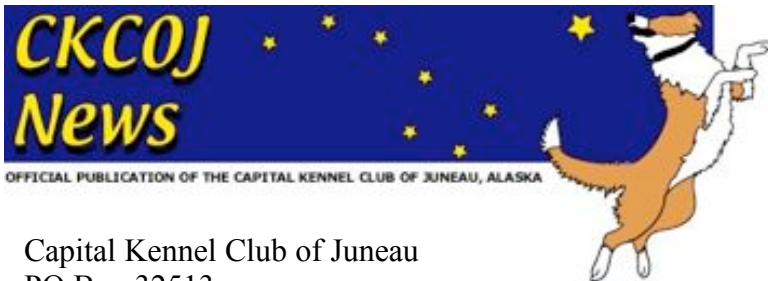
