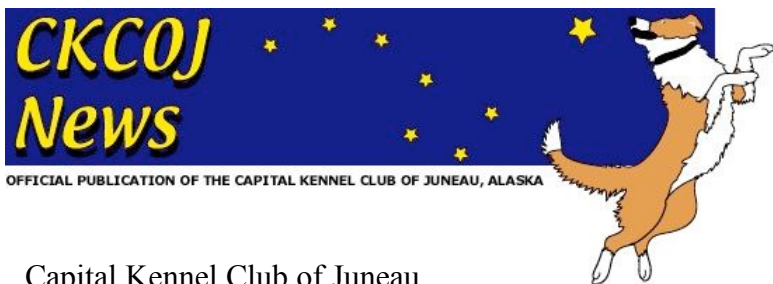
MINUTES
CKCoJ Monthly Meeting
Thursday, May 22, 2008 – Valley Library

- I. Call to Order: This regular monthly meeting was called to order by Grose, President, at 6:35 p.m.
Board members present: Grose, Uttermohle, Barnes.
Members present: Stephens, McGowan.
- II. Consent Agenda
 - a. Approval of the Agenda – add items: III. a. Records; IV. a. Obedience DVD Purchase; IV. b. Member At Large. Approved.
 - b. Approval of Previous Minutes, Mar.20, 2008 – approved.
 - c. Acceptance of the Treasurer’s Report – the report as submitted by Utermohle was approved.
 - d. Approval of New Members – None.
- III. Discussion Items
 - a. Records – Barnes asked if she had erringly passed on documents to the club Historian, Kalbaugh, that should be kept by the Board. After discussion it was decided that Barnes should contact Kalbaugh and retrieve the class registrations and trial results documents that are less than three years old. She will contact Kalbaugh.
- IV. Action Items
 - a. Obedience DVD Purchase - Grose made the request for Kalbaugh. She requests the club purchase 2 dvd’s for her Foundations Class; 1) Choose to Heel, and 2) Positively Fetching. The cost for both including shipping is approximately \$115. After a brief discussion the Board approved the purchase.
 - b. Member At Large – Sue McGowan consented and was elected to finish the term which expires this coming October.
- V. Routine Updates
 - a. Event Planning – Stephens reported that the Obedience Trial for 6/7-8 was on schedule. It will be at Glacier Valley covered playground. Kalbaugh will be the judge, the stewards are lined up. Hoffman is the trial secretary. It should be a small trial.

Stephens reported that the Foundation classes went well. Progress was evident there was an amazing difference in the dogs between start and finish of the class. There will be another level one class.

Stephens also reported that the Fun Matches went well.

 - c. Correspondence – Utermohle displayed the mail received over the past month. There were no items of business.
