MINUTES
CKCoJ Monthly Meeting
Thursday, July 17, 2008 – Valley Library

- I. Call to Order: This regular monthly meeting was called to order by Grose, President, at 6:35 p.m.
Board members present: Grose, Uttermohle, Barnes, McGowan.
Board members absent: Nelson.
Members present: Stephens, Kalbaugh.

- II. Consent Agenda
 - a. Approval of the Agenda – add items: III. a. Agility Venues; and, III. b. Pet Photos with Santa. Approved.
 - b. Approval of Previous Minutes, June 19, 2008 – approved.
 - c. Acceptance of the Treasurer’s Report – the report as submitted by Uttermohle was approved.
 - d. Approval of New Members – Sue Fry, Sarah Felix, and Mariah Hulse; approved.

- III. Discussion Items
 - a. Agility Venues – Uttermohle suggested the club find additional covered areas. Gross has spoken with personnel at the new Dimond Park Field House and we have been added to their list of interested users. They charge 50-55 dollars per hour. This may be a possible venue for trials but the cost is too much for practices. The discussion turned to the possibility of having a storage unit at Melvin Park and requesting space from CBJ for storage that all dog groups could use.
 - b. Pet Photos with Santa – Kalbaugh and Stephens are beginning plans for this year’s event. Their goal is to streamline the process. They found an internet company, Dot Photo, that photos can be uploaded to and remain on the site for 90 days. Customers can then either download, or have mailed to them, the prints they want. The club sets the price for the prints and receives funds for those sold. An account will need to be setup with Dot Photo. They will be looking for 4-5 volunteers to assist at this year’s event and will be contacting Jack (Santa) soon to find out his availability. They are considering holding the photo shoot for two weekends.

Nominating Committee Looking for Club Members to Fill Two Positions on CKCOJ Board

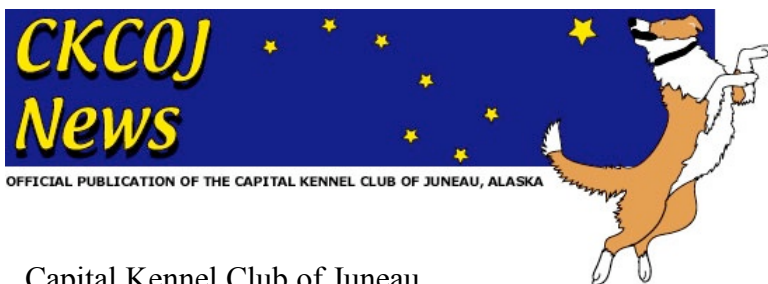
