**I. Call to Order.** 6:32 pm. Board members present: George Utermohle, Jill Grose, Pam Nelson, Camille Stephens. Other members present: Patti Kalbaugh.

  - 1. Obedience
    - (a) March 2009 Obedience Trial – update (Patti Kalbaugh). Everything is on track and in order.
    - (b) Future Trials (Camille Stephens). Nothing specific to report. See UKC Rally item below.
  - 2. UKC Rally – Patti Kalbaugh and Camille Stephens suggested that we consider holding a UKC Rally trial or a combination Rally and Obedience trial this summer. Patti has been in contact with Lisa Barnard and she is available the last three weekends in July. By unanimous consent, Patti was authorized to contact UKC and make the necessary commitments for a trial. There was also some discussion about how to boost awareness and interest in Rally. Suggestions included: having an informal lunch meeting open to anyone interested in helping to get Rally going; scheduling an evening practice for those interested in Rally. At this time we do not have anyone willing to teach a class. The hope is that more experienced trainers will be willing and available to help those just starting out.
  - 3. Agility – update; annual dues for club need to be paid to NADAC. Camille reported that Kim Hastings had volunteered to serve as Trial Chair. She also relayed the reminder from NADAC that our club’s membership dues were past due. Jill reported that interest in the upcoming classes is lower than expected. She felt that it was best to postpone any decisions about a trial and renewing the club’s NADAC membership until we see how much interest there is among agility people. No action taken pending update from Jill.

4. Classes/Practices – updates on current classes/practices and plans for future classes/practices. Jill will summer practices at Glacier Valley covered playground, Wednesdays, 6-8pm and Auke Bay covered playground, Saturdays, 10am-NOON. An additional weeknight practice will be scheduled for Rally practice, day and time to be determined. Fee for participation in practices will be \$30 for the summer.

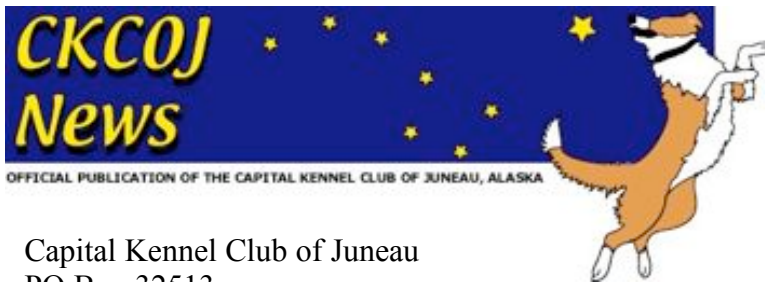
