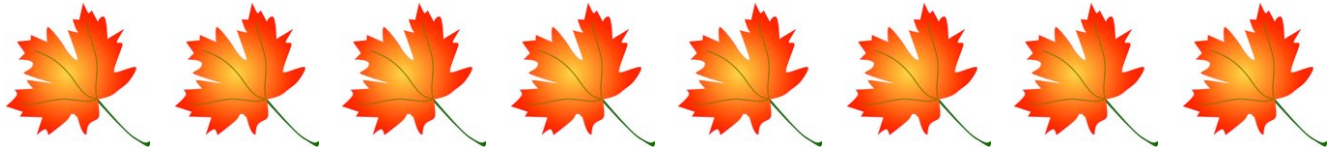


# Wags and Brags

Regular Monthly Meeting: called to order at 7:05pm; New Board members present: Camille Stephens, George Utermohle, Sue McGowan, Mike Higgs, Sandy Harris; other CKCoJ members present, Susan Hoffman, Diana Higgs
  
- II. Designate Board Officers  
Executive Session: began at 6:35pm to determine CKCoJ officers for the next term: President, Camille Stephens; Vice President, George Utermohle; Secretary, Sue McGowan; Treasurer, Mike Higgs; Member-At-Large, Sandy Harris. Executive session adjourned at 7pm.
  
- III. Consent Agenda
  - A. Approval of the Agenda- 2 additional discussion items: Susan Hoffman- possible change to CKCoJ By-Laws Articles 5 and 8; Mike Higgs- class/testing for Canine Good Citizen designation; agenda approved by Unanimous Consent (U/C).
  - B. Approval of the Previous Minutes – September 17 meeting: approved by U/C.
  - C. Acceptance of the Treasurer’s Report: approved by U/C.
  - D. Approval of New Members: none.
  
- IV. Discussion Items
  - A. Susan Hoffman presented revised language for Articles 5 and 8 of By-Laws for discussion to add the CKCoJ Announce Yahoo group as another official means for communicating club business to members; Mike Higgs suggested adding language to By-Laws directing people to the CKCoJ Policies for details on official club communications. Hoffman will rework the language of the proposed changes for consideration next month.
  - B. Discussion about clarity of messages written for members and how new members may not be familiar with some CKCoJ terms. Sandy Harris will investigate which terms should be defined for inclusion in a glossary.

Air North may reinstitute service between Juneau and Whitehorse, YT in the spring of 2010 (Juneau Folk Festival); some discussion about partnering with Whitehorse Kennel Club (also acquiring sponsors) and holding events where there is most interest. Mike Higgs will work on poll questions to try to further determine membership areas of interest.

2. Agility – update. Possibly hold an Agility trial in July, after July 4th weekend, before rains come in August.
3. Classes/Practices – updates on current classes/practices and plans for future classes/practices. Puppy Kindergarten class for November/December nearly full. Patti Kalbaugh may conduct a Beginning Rally class after Puppy-K class. Susan Hoffman noted that the next set of practices at Mt. Jumbo begin November 14 through December 26. Obedience “run-thrus” in October, November, December (dates on website and in newsletter). Mike Higgs asked about holding another class and testing for Canine Good Citizen (CGC); Marty Messick may do another test, Mike will contact Marty to find out more details.

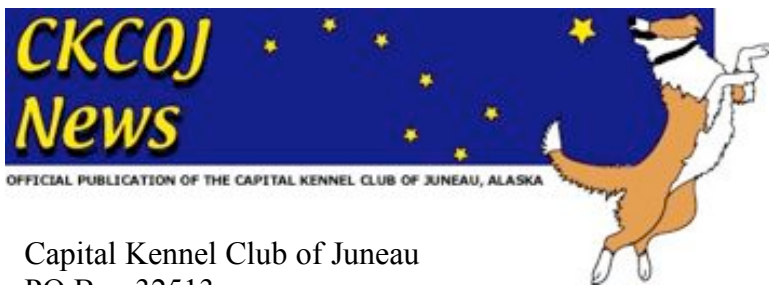
