DRAFT MINUTES
Capital Kennel Club of Juneau (CKCoJ)
MONTHLY MEETING
December 17, 2009
Downtown Library, Small Conf. Room, 6:30 pm

- I. Call to Order at 6:35pm; board members present: Camille Stephens (C.S.), George Utermohle (G.U.), Sue McGowan (S.M.), Mike Higgs (M.H.)
- II. Consent Agenda
 - A. Approval of the Agenda: approved (U/C) , with additions (M.H. add D., E., F., under Discussion Items; C.S. added Patti Kalbaugh revisions under Action Items)
 - B. Approval of the Previous Minutes- November 19, 2009 meeting: approved (U/C), with additions and changes added by M.H.
 - C. Acceptance of the Treasurer’s Report: approved (U/C), with suggested format changes
 - D. Approval of New Members: none
- III. Discussion Items
 - A. Review possible language change to By-Laws, Policies (S. Hoffman): discussion centered on the “final” draft, submitted via e-mail by Susan Hoffman prior to this meeting, with regard to changes to Article III, Sect. 1; Article V, Sects. 3 and 7 and Policy 009; motion made by G.U. to approve changes, seconded by M.H., approved U/C. Also, motion made by G.U. to adopt Policy 023 as amended, seconded by M.H., approved U/C.
 - B. Adding definition of terms/glossary (S. Harris): Sandy Harris submitted a preliminary draft of terms/glossary via e-mail . Carryover.
 - C. Reminder- CKCoJ Christmas party at Jill Grose’s house on December 20th at 4pm.
 - D. Sandy Beach clean-up: M.H. proposed that CKCoJ members assist Grateful Dogs of Juneau during the Apr., May clean-up at Sandy Beach. Board members present agreed it would be a good thing to coordinate efforts in the spring.
 - E. CKCoJ library inventory: M.H. thought it would be a good idea to update the inventory of all club library materials. Board members present agreed. S.M. will check with Hazel Reynolds to locate the CD and booklet ordered for teaching puppy classes.
 - F. CKCoJ website update: M.H. noted the club website has many links to different sites that are outdated and no longer relevant. G.U. and C.S. will look at and work on updating the CKCoJ-Announce and the club website.
- IV. Action Items- C. S. noted a request from P. Kalbaugh to revise Puppy and Basic registration forms by adding a question field, i.e., would you (members) like to be invited to join a low volume public announcement e-mail list for CKCoJ events, such as classes, pet photos, and Trials? Kalbaugh offered to make the change to the forms. Discussion centered on the size of the registration form and whether there is room for another question. Board members present agreed by U/C to allow Kalbaugh to add the question to the registration forms.

1. Obedience/Rally: on track for January Trials, although there are no entries yet. Additionally, C.S. proposed putting future club events on a regular schedule (Mar.-Apr.), or scheduling events one year in advance- to be carried over for further discussion.
 - (a) Future Obedience/Rally Trials- update: nothing planned after April Obedience and Rally Trials
2. Agility- update: no activity
3. Classes/Practices- updates on current classes/practices and plans for future classes/practices: Patti Kalbaugh will teach a Rally Level I class beginning January 4, first four Mondays in January; Susan Hoffman gave an update (via e-mail) with regard to Friday Rally practices at DZ- going well, with five members participating; Susan also noted that Saturday practices at Mt. Jumbo will resume on January 23rd, with four members already committed to those practices. The practice registration form is on the club's website. S.M. noted that Hazel Reynolds anticipates teaching another puppyK class starting in February.
4. Pet Photos with Santa- update; C.S. submitted a breakdown of costs and monies received from the pet photos with Santa, including income from '.photos' to-date; the upshot is the club made money. Thank yous were extended to Camille Stephens and Patti Kalbaugh for their effort.
5. CGC - Class and Exam- update: carryover to next meeting.

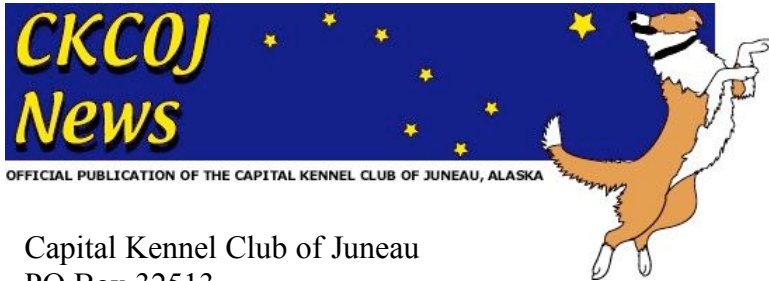
