DRAFT MINUTES
CKCOJ MONTHLY MEETING
11-18-10
Mendenhall Valley Library, 6:30 PM

I. Call to Order: meeting was called to order by George Utermohle at 6:33pm; board members present: George Utermohle, Mike Higgs, Sandy Harris, Sue McGowan; board member absent: Camille Stephens. Other CKCoJ members present: Hazel Reynolds, Jill Gross

II. Consent agenda

- A. Approval of the agenda: additions to agenda by Mike Higgs: suggested that item C. under IV Action Items be combined with item A.; added 5. Seminars, to agenda item V. A. Routine Updates/Reports; moved item E. 2010 ADPT conference report under III. Discussion Items, to V. Routine Updates/Reports, item 6. Agenda approved by U/C, with the addition of the aforementioned items.
- B. Approval of the minutes from the previous meeting on 10-21-10: approved with no objections (Unanimous Consent, U/C).
- C. Acceptance of the treasurer's report: MH noted that this report adds in expenses from August and September, 2010 that relate to this fiscal year, beginning October 1, 2010. MH also provided a separate report indicating the status and reimbursement of the 2009 and 2010 Reynolds agreements. Some discussion on how crossover projects (from one fiscal year to another) should be tracked and reported on (from project to project). Treasurer's report accepted, without objection.
- D. Approval of new members: some discussion to clarify that a single, adult membership means one adult, one dog; Jessica, Dan Spady upgraded their single membership to family, as they have two dogs in the Manners class; Edie Barnes, renewing member; Kathryn Kurtz, new member- all approved by U/C.

III. Discussion Items

- A. Judge's contract template: discussion about using the same judges contract template that was sent to board members by Patti Kalbaugh for agility judges; this item to carryover for final action at December, 2010 board meeting.
- B. Storage for equipment: MH reported on his researching cheaper places to store CKCoJ equipment- require heated unit, paid for this year with fees increased by \$20; discussion and decision to keep status quo with current storage unit on Shaune Drive.
- C. Photos with Santa: MH noted that he has a photographer in mind to ask about donating his/her time to take pictures and also will check with "Jack" as to his availability to play Santa.
- D. Christmas Party: not going to be at Jill's house this year (after 16 years previously). Jill agreed to check availability of other venues and will report back.

E. 2010 ADPT Conference: moved to agenda number V. Routine Updates/Reports, item 6.

IV. Action Items

- A. Miscellaneous bills/NADAC renewal: MH reported that the CKCoJ business license has been paid for 2 years; MH also authorized to renew CKCoJ membership in NADAC.
- B. Long term agility equipment needs: discussion with MH and Jill Grose about upcoming agility equipment needs, i.e., weave poles (can no longer be staked); tunnel bags (how many, where to get heavy duty stitching of bags) and new tires; S.H. moved to approve purchase of tires, passed by U/C- authorized \$325 to be spent for this; other items to carryover for discussion, possible action at December meeting.
- C. NADAC renewal: see item A.
- D. Scheduling for 2011 trials: Rally/Obedience trial upcoming in February; Agility trial in June; Rally/Obedience trial in August or September.

V. Routine Updates/Reports

 - 3) Classes/practices: Manners class underway; probable puppyK class upcoming end of January, 2011.
 - 4) CGC: no discussion
 - 5) Seminars: MH noted that he would like to get a sense of membership interest in attending certain dog-related activities under club sponsorship, i.e., a possible Handling seminar (with Lisa Barnard)- he may post an interest-inquiry on the club website.
 - 6) 2010 ADPT Conference: Hazel Reynolds reported on her attendance at the ADPT Conference held this year in Atlanta, Georgia and brought many sample items that were given away at the conference. Reynolds noted that the class she found most informing was a class about reintegrating problem dogs back into society. Also, Reynolds talked to other conference attendees about their interest in coming to Juneau (Gail Fisher, Pia Silvani).

There was additional discussion about using Auke Bay Elementary School gym for club activities, if there was some way to lower the cost of renting that facility. Reynolds had spoken with Joyce Kitka, Director of Community Schools who said that the facility would be fine for using as a classroom, or even trials. Jill Grose will look into the possibility of lower cost.

B. Committee Reports/Updates: no discussion.

C. Correspondance: SM passed over a packet of UKC forms to MH.
