DRAFT MINUTES
CAPITAL KENNEL CLUB of JUNEAU (CKCoJ)
MONTHLY MEETING
December 16, 2010
Downtown Library, Small Conference Room 6:30 PM

I. Call to Order: meeting called to order at 6:35pm. Board members present: Camille Stephens, George Utermohle, Mike Higgs, Sandy Harris, Sue McGowan. Other club members present: none.

II. Consent agenda

A. Approval of the agenda: Under III. Discussion, Camille Stephens added item D. Doggie Dollars Coordinator; Mike Higgs, added item E. Doggie Dollar Policy and item F. Seminars. Agenda then approved, with additions, by Unanimous Consent (U/C).

B. Approval of the minutes from the previous meeting on 11/18/2010: Delete the words "...one dog" in paragraph D. Approval of new members, item II. Consent Agenda. After change/deletion, minutes from previous meeting approved by U/C.

C. Acceptance of the treasurer's report: approved by U/C.

D. Approval of new members: no new members; several membership renewals. Mike Higgs noted that the membership list on-line is now current. Members should contact Mike Higgs if their name is not listed.

III. Discussion Items

A. Judge's contract template (carryover): discussion about tweaking sample NADAC contract to suit CKCoJ needs. George Utermohle moved that CKCoJ prepares a model contract template the club can use for future events, Sandy Harris seconded the motion. Camille volunteered to put one together, after making minor changes to the sample NADAC contract. Carryover

B. Photos with Santa (carryover): Mike Higgs reported that the club may not make any money from the photos with Santa, or may just break even. Mike wanted to make special note of and thank the efforts put forth by Jamie Criss and Sabrina Nelson, who volunteered their time the whole weekend. Mike also noted that he had developed a what-to-do list for future club pet photos with Santa and hopefully, in the future, this event can be planned earlier.

C. Christmas Party (report): at Mi Casa restaurant, 6pm, December 23rd; includes dog-related gifts of not more than \$25, to be distributed through a cutthroat gift exchange.

D. Doggie Dollars Coordinator: Camille Stephens noted that Cheryl Jebe, coordinator for CKCoJ Doggie Dollars has resigned from the (informal) position. Camille and the rest of the board would like to acknowledge and thank Cheryl for her long-time volunteer service for the betterment of the club. Sandy Harris will talk to John Sivertson about taking on the Doggie Dollar coordination. Carryover

E. Doggie Dollars Policy: Mike Higgs noted that the Doggie Dollars policy information occurs in various places on the club website and that it would be helpful if someone would organize and consolidate all the information so that it can be all in one place. No changes to the policies at this time, just a reorganization of the information.
