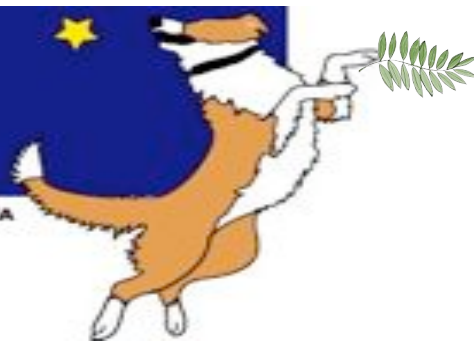

**CKCoJ MONTHLY MEETING**  
**January 20, 2011**  
**Mendenhall Library Conference Room, 6:30pm**

I. Call to Order: meeting called to order at 6:34pm. Board members present: Camille Stephens, Sue McGowan, Sandy Harris, George Utermohle. Board member absent: Mike Higgs

II. Consent agenda

- A. Approval of the agenda: approved by unanimous consent (U/C)
- B. Approval of the minutes from the previous meeting on 12/16/2010: approved by U/C
- C. Acceptance of the treasurer's report: discussion about having the treasurer (Mike Higgs) include an account of the status of the Reynolds contract along with the monthly report. Treasurer's report was then approved by U/C.
- D. Approval of new members: temporary provisional approval of new members : Kimberly, Miranda Vaughn.

III. Discussion Items: Judge's contract template (carryover): Camille Stephens furnished a blank judge's contract template that included changes suggested at the December meeting. George Utermohle suggested adding a line that showed whether or not there are additional conditions attached to the contract, with a place to check whether there are attachments, i.e., Additional Conditions attached: \_\_\_ Yes \_\_\_ No. Sandy Harris suggested that SASE be spelled out. Camille will make the changes and give a "final" template for George to post in .pdf format that may be edited to suit.

- A. Long term agility equipment needs- polebags (carryover): item carried over for further discussion when Mike Higgs is present.
- B. Doggie Dollar Coordinator (carryover): Sandy Harris reported that John Sivertson has agreed to become the new coordinator for Doggie Dollars, since Cheryl Jebe resigned from the voluntary position. Camille will send a thank-you note to Cheryl on behalf of the CKCoJ.
- C. Doggie Dollar policy reorganization (carryover): some discussion about the need for reorganization to policy and it was decided not to pursue at this time- issue resolved.
