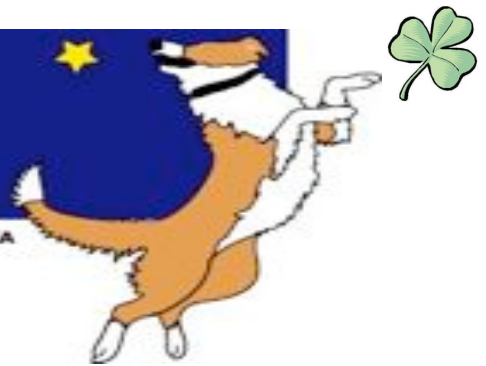

CKCoJ MONTHLY MEETING
February 17, 2011
Downtown Library, Small Conference Room, 6:30pm

I. Call to Order: meeting called to order at 6:36pm. Board members present: Camille Stephens, Sue McGowan, George Utermohle, Mike Higgs, Sandy Harris. Other club members present: John Sivertsen, Jamie Criss

II. Consent agenda

A. Approval of the agenda: Under III. Discussion Items, Camille added B. Key Inventory; under V. Routine Updates/Reports, George added 5) Housekeeping. Agenda approved by Unanimous Consent (U/C) with additions as noted above.

B. Approval of the minutes from the previous meeting on 1/20/2011: approved U/C.

C. Acceptance of the treasurer's report: approved U/C.

D. Approval of new members: Mari Meiners provisionally approved pending receipt of check; the board officially approved members Kimberly and Miranda Vaughn, who were provisionally approved at January 20, 2011 meeting.

III. Discussion Items

A. Judge's contract template (carryover): in progress, final version to be given to club webmaster.

B. Key Inventory: Camille produced a key inventory for the storage unit in Lemon Creek, which was given to her by Jill Grose. Camille suggested that the club needs to recover all spare keys, especially from non-members and to have two additional keys made. Sue said she get the keys made. Camille will make a new inventory list of key-holders. Camille also noted that the club needs a second key for the post office box- Mike will follow up.

IV. Action Items

A. Long term agility equipment needs- polebags (carryover): Mike reported that Patti Kalbaugh made 30 saddle bags for the agility tunnel, 15 blue, 15 yellow; bags came in under budget. Jamie offered to make 3 pole bags, once she obtains a sewing machine. Contactacoat rubberizing agent has been approved by NADAC.

B. Mike Higgs noted that dotphotos.com has not yet sent a check for the money owed to CKCoJ (Pet Photos with Santa). Camille said she would follow up and contact dotphotos.com.

George volunteered to complete both required forms. George also noted that the club's property inventory list should be updated for insurance purposes.
