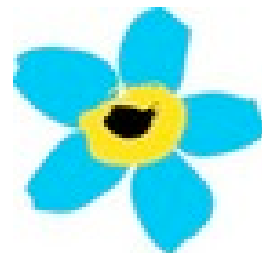

DRAFT MINUTES

CKCoJ MONTHLY MEETING

July 21, 2011

Valley Library Conference Room, 6:30pm

- I. Call to Order: at 6:30pm. Board members present: Camille Stephens, George Utermohle, Sandy Harris, Sue McGowan; board member absent: Mike Higgs. General member present: Jamie Criss.

- II. Consent agenda
 - A. Approval of the agenda: Camille added C. Agility and D. Flyball to III Discussion Items. Camille added A. Pet Photos with Santa to IV. Action Items; George added B. Website to IV. Action Items.; the agenda was approved by Unanimous Consent (U/C), with additions as noted.
 - B. Approval of the minutes from previous meeting, 6/16/2011: approved by U/C.
 - C. Acceptance of the treasurer's report: approved by U/C, with any questions deferred until Mike Higgs is present.
 - D. Approval of new members: Bill and Susan Clutton.

- III. Discussion Items
 - A. Insurance/equipment inventory follow-up: deferred discussion until Mike Higgs is present.
 - B. Nominating Committee: Sandy Harris, Jamie Criss, Sue McGowan. Jamie reported she may not be available to run for office since she may be moving out of town. George will not run for office once his term is up; no one knows for certain if Mike Higgs plans to be available for another term. Sandy Harris will be available for another term.
 - C. Agility: general discussion about the future of the Agility program.
 - D. Flyball: general discussion as to whether or not CKCoJ should allow a merger with the Juneau Flyball Club and how that would affect both entities (7/20/2011 e-mail request from Leslie Peters, founder and president of the Juneau Flyball Club). Camille requested that each board member read the response she made to the questions posed by Leslie Peters and give Camille feedback prior to this Monday; Camille will e-mail Leslie to let her know the board needs to consider further, as there was not enough time for an in-depth discussion at tonight's meeting.

- IV. Action Items
 - A. Pet Photos w/Santa: Camille researched two on-line photo companies (Smug Mug, Photo Moto) with regard to the CKCoJ pet photos with Santa club fund-raiser during the holidays. Patti Kalbaugh has agreed to be the photographer, but not to organize the event; Camille volunteered to organize and to distribute the various jobs among other volunteers.

Camille asked if the club is willing to spend \$150/yr. for the on-line photo service- no action taken to expend money for this at this time. Camille will e- mail "Jack" to find out if he is still interested in playing Santa for the photos.

- B. Website: George reported that the club's domain name (ckcoj.org) is registered through NetworkSolutions.
