CBJ Risk Management requires a \$1,000,000 liability endorsement to CKCoJ insurance policy naming CBJ as Additional Insured- cost to CKCoJ, an additional \$750 for coverage for the season (May, June, July, August). The board will investigate further and will revisit at May meeting.
