III. Action Items

- A. Nominating Committee for two board positions: Secretary, Vice President. Nominating Committee will consist of Sandy Harris, Sue McGowan, and Hazel Reynolds.

1) Obedience/Rally:

- a) September 15-16 trial: Sandy has contacted judge, Arlene Courtney-Gina Vose will pick up the judge at the airport; the judge will stay at a B&B in Douglas. Camille noted that Patti Kalbaugh has donated several prizes to give away at the trial; there will be a Fun Match at Mt. Jumbo on September 8. Camille also noted that CBJ Parks & Rec wants a 3-hr. block of time on Saturday, after 4pm. All agreed that even though it may cause a hardship to the club, it can be accomplished.
- b) Mike Higgs mentioned that he and Diana (Higgs) are tentatively planning to teach a 4-6 wk. Rally class- details to be announced after the first of the year.
- c) Camille discussed the possibility of a future Obedience/Rally trial next summer with Gina Vose judging Obedience and Patti Kalbaugh judging Rally. Sue will find out about availability of Auke Bay covered playground for that trial- currently under construction.
