Capital Kennel Club of Juneau (CKCoJ) MONTHLY MEETING
November 15, 2012

I. Call to Order: 6:36pm. Board members present: Mike Higgs, Sandy Harris, George Utermohle, Carol Lemon, Sue McGowan.

II. Consent agenda

- A. Approval of the agenda: approved by Unanimous Consent (U/C).
- B. Approval of the minutes from previous meeting, 10/17/2012: approved by U/C.
- C. Acceptance of the treasurer's report: approved by U/C.
- D. Approval of new members: no new members to approve.

III. Action Items

- A. Pet Festival: Mike gave a report on the GHS Pet Festival, thanking Grateful Dogs of Juneau for allowing CKCoJ to share their table.
- B. Report on cost of award pins- Sandy (Carryover): Sandy reported that UKC pins for Rally and Obedience cost \$4/ea.; NADAC pins cost \$8.50/ea., CGC pins cost \$7/ea. Discussion centered on club members getting their request for award pins submitted in a timely manner. The board approved a not-to-exceed amount of \$25.00 to purchase award pins for Mike and Diana Higgs that were earned in 2012.
- C. Date for special meeting to discuss fee matrix- Mike (Carryover): Mike will post to CKCoJ- announce a request for members interested in participating in a review of the current fee matrix.
- D. Letter request for Flyball refund (Leslie Eagle): the board approved a refund of the Flyball fees to Leslie Eagle, in the amount of \$251.35. The refund will have three conditions that must be met prior to refunding the amount. The conditions are as follows: 1) Leslie must remove the Juneau Flyball affiliation with CKCoJ from her Google website; 2) returning the CKCoJ flyball practice box, and 3) return the paperwork from NAFA to the CKCoJ treasurer, George Utermohle. Sue will draft a letter for Mike's signature.

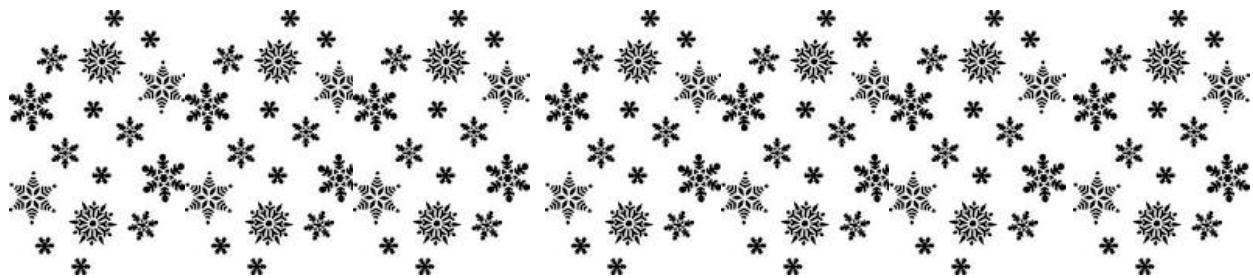
