The annual Holiday Pet Photos fundraiser for CKCOJ will began last Saturday, November 30.

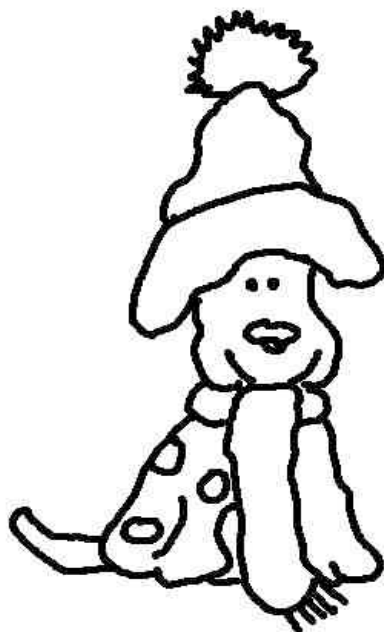
The next Holiday Pet Portrait sessions will be Sunday, December 8,

CGC test/evaluations will be scheduled every 15 minutes. Sign up for test times will be available before the test.

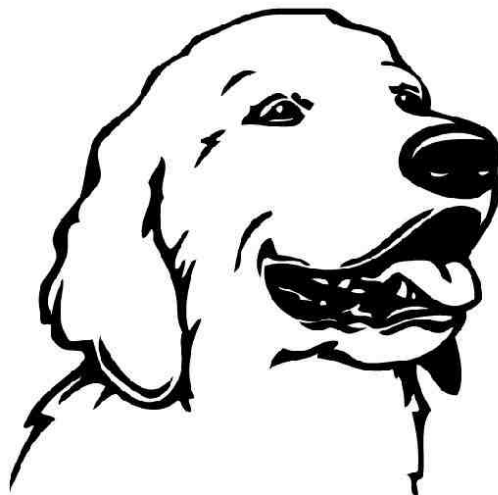
CGC Evaluator: Marty Messick **Cost:** \$15.00 per test per dog
