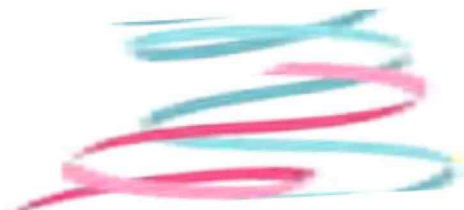

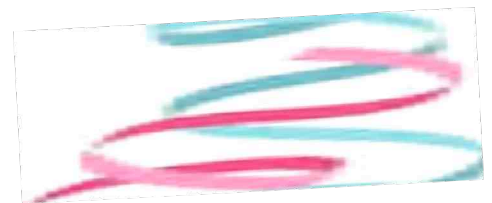

I. Call to Order: 6:40pm. Members present: Diana Higgs; Judy Gustafson; George Utermohle and Mike Higgs. Members absent: Sue McGowan and Marty Phelan. Side note (not included in October minutes) .. In Executive Session after the CKCoJ annual meeting on October 6, 2013, Board positions were filled as follows: President, Diana Higgs; Vice President, Judy Gustafson; Secretary, Sue McGowan; Treasurer, George Utermohle; At-Large, Marty Phelan.

II. Consent agenda

- A. Approval of the agenda: Judy added "Fund Raisers" to Discussion Items, approved as amended by Unanimous Consent (U/C).
