II. Consent agenda

A. Approval of the agenda: Mike added Agility training videos to III. Action Items, A.; also, Mike added Mt. Jumbo coordinator to III. Action Items, B. Delete item B., under IV. Discussion Items. Sue made a motion to approve the agenda, with additions; Marty seconded. Agenda approved by Unanimous Consent (U/C).

B. Approval of the minutes from February meeting, 3/20/2014: approved by U/C.

C. Acceptance of the treasurer's report: Sue made a motion that the Treasurer's report be accepted; Marty seconded. Approved by U/C.

D. Approval of new members: Barbara Pritchett, Katy Giorgio- approved by U/C.

A. Agility training videos: Mike gave an overview of the various aspects and options available for Agility training. Also, interest was expressed about learning "Distance Training" and the possibility for using videos as supplemental training tools in order to focus skills. No action taken.

A. Field storage container for Agility- update status on using Patti Kalbaugh's trailer- not available. Mike will inform Agility people that the equipment will have to be hauled back and forth from the CKCoJ storage unit until mid-May, when the trailer that he and Diana ordered will arrive and be available to use.

B. Possible rate increase to CBJ facilities: George encouraged everyone to contact the CBJ assembly to express how important it is to the CKCoJ to keep Mt. Jumbo gym open.

C. Dangerous Dog designation- input to CBJ: George also encouraged CKCoJ members to give the assembly input with regard to rehabilitating dogs who have been given a Dangerous Dog designation.

1) Obedience/Rally: Mike presented a cost proposal for a September, 2014 Obedience and Rally trial, with a judge (Kim Alexander-Thomas) coming from Buffalo, NY. May 2014 trial is set.
