If you do not agree to all terms, conditions, rules, policies or procedures, you cannot use or access the services or participate in the events. Capital Kennel Club of Juneau reserves the right, at its sole discretion, to modify or replace any of the terms or conditions of this terms of service at any time.

- 1. WAIVER OF LIABILITY** - I understand participating in events held or sponsored by the Capital Kennel Club of Juneau may include potentially hazardous activities. I assume all risks for myself and my dog(s), which include falls, contact with other participants, the

weather, the road or trail conditions and traffic. I assume all risks associated with participating in any/all events held or sponsored by the Capital Kennel Club of Juneau. I hereby release the Capital Kennel Club of Juneau of any and all responsibility for damage or personal injury that may occur as a result of participating in an event.

2. **CONDITION OF DOG** - In events where your dog(s) is present, I certify and represent that:
  - My dog(s) is not a hazard to other dogs or persons and does not exhibit aggressive behavior that poses a danger to people or other dogs
  - My dog(s) is current on all puppy and booster vaccinations, and rabies vaccinations according to state law.
  - My dog(s) is in good health.
  - I accept personal responsibility for any and all actions my dog(s) makes.
3. **YOUR REGISTRATION OBLIGATIONS** - To be a registered user of the Services, you agree to: (a) provide true, accurate, current and complete information about yourself as prompted by the Site registration form (the Registration Data). If you provide any information that is untrue, inaccurate, not current or incomplete, or Capital Kennel Club of Juneau has reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, Capital Kennel Club of Juneau has the right to suspend or terminate all of your registrations and refuse any and all of your current or future use of the Services (or any portion thereof). Capital Kennel Club of Juneau is concerned about the safety and privacy of all its users, particularly children. For this reason, you must be at least 18 years of age, or the legal age of majority where you reside if that jurisdiction has an older age of majority, to register for an event.
4. **YOUR EVENT PARTICIPATION OBLIGATIONS** - When participating in Capital Kennel Club of Juneau events, certain standards of behavior are expected from the handler and their dog(s). These standards have been established to protect the health and safety of all people and dogs involved in the event. These standards also seek to ensure fair participation by all registrants of the event.
  - **Control of Dog** - Handlers must keep their dogs under control at all times. When not actively involved in an exercise, you agree to keep your dog(s) leashed, kenneled or otherwise restrained. You will not allow your dog(s) to wander unleashed. Dogs may be off-lead during off-lead exercises only if the handler has competent control.
  - **Control of Noise** - In order to ensure that all participants are able to hear the instructor, handlers and their dogs are expected to manage their noise level. In some venues, the acoustics require near silence in order to hear the instructor. You agree to keep your voice and your dog(s) noise to a level that does not interfere with instruction. If there is difficulty in controlling the noise, you will take your dog out of the area or facility until the noise ceases.
  - **Equipment Setup/Tear-Down** - You agree to assist with the setup and/or tear-down of equipment unless excused by the instructor/facilitator. You should arrive early enough or remain late enough to provide this assistance. Your dog should be kenneled or otherwise restrained during setup and tear-down.
  - **Instructor/Facilitator Directions** - You agree to follow all directions of the instructor or facilitator. This includes instruction for class, exercises, setup/tear-down, noise control and behavioral issues. The instructor/facilitator also reserves the right to remove handlers and their dogs for behavior issues or non-compliance with directions. This removal may be for anywhere from a single exercise up to the remainder of the event sessions.
5. **RIGHT OF CANCELLATION** - The instructor, facilitator or the board retains the right to cancel this entire registration or any remaining sessions of this registration for non-compliance with these terms and conditions. Refunds will be made in accordance with the current Policy 21 - Refunds (see [Policies 001 through 023](#)).
6. **PRIVACY** - Any information submitted or provided by you to the Services may be publicly accessible. You should take care to protect private information or information that is important to you. Capital Kennel Club of Juneau shall not be responsible for protecting any such information and is not liable for the protection of privacy of electronic mail or other information transferred through the Internet or any other network that you may use.
