Entry Information:

Entries will be accepted up to and including the day of the trial. Closing Date for Pre-entries is Friday, January 26, 2024 at 5 PM. Day of Trial entries accepted after pre-entry deadline. Entries received after the pre-entry deadline must pay the Day Of Show Fees

Emailed entry forms will be accepted from out-of-town entrants. Payment from out-of-town entrants is due before the beginning of first trial in which the entrant is entered.

Move Ups: Move ups will be accepted at all trials. Please notify the trial secretary no later than 15 minutes before judging begins.

Fees: Please contact the Trial Secretary if you have questions about the entry fees.

Pre-entry: \$25 per dog for each class entered and \$15 for second entry same dog/same trial. Jr handler \$25 per dog and no fee for same dog/same trial.

Day of trial: \$30 per dog for each dog entered and \$20 for second entry same dog/same trial. Jr handler \$30 per dog and \$20 for second entry same dog/same trial.

Payment: Cash or check made out to CKCOJ. Sorry, no credit or debit cards accepted.

Refund Policy: Refunds will be granted when requested by the participant for any reason prior to exhibiting the dog in a trial.

Awards for Licensed Trials: Ribbons for High in Trial, First through Fourth placement, and qualifying scores.

Ring Information: Indoor Facility. Hardwood floor, partially matted, free standing plastic ring gates, standard size ring for obedience.
